ANNUAL GENERAL MEETING TO BE HELD ON THURSDAY, 28 APRIL 2022, AT 10.00 A.M. (SINGAPORE TIME)

Singapore – 1 April 2022

1. BACKGROUND

APTT Management Pte. Limited (the "Trustee-Manager"), as Trustee-Manager of **Asian Pay Television Trust ("APTT")** refers to:

- i) the COVID-19 (Temporary Measures) Act 2020, which enables the Minister for Law by order to prescribe alternative arrangements for listed entities in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means; and
- the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (as amended and/or modified, the "Temporary Measures Order") which sets out the alternative arrangements in respect of, *inter alia*, general meetings of business trusts.

2. DATE, TIME AND CONDUCT OF AGM

The Board of Directors of the Trustee-Manager wishes to inform unitholders that pursuant to the Temporary Measures Order, APTT's annual general meeting in respect of the financial year ended 31 December 2021 ("**AGM**") will be convened and held by way of electronic means on 28 April 2022, Thursday, at 10.00 a.m.

3. NOTICE OF AGM, APPENDIX IN RELATION TO THE PROPOSED TRUST DEED AMENDMENTS AND PROXY FORM

Printed copies of the Notice of AGM, Appendix to the Notice of AGM ("**Appendix**") in relation to the Proposed Trust Deed Amendments and Proxy Form have been despatched to unitholders. The Notice of AGM, Appendix and Proxy Form are also made available to unitholders by electronic means via publication on the website of the SGX-ST at the URL <u>https://www.sgx.com/securities/company-announcements</u> and APTT's corporate website at the URL <u>https://investor.aptt.sg/newsroom.html/year/2022</u>.

4. NO PERSONAL ATTENDANCE AT AGM

Unitholders will **<u>not</u>** be able to attend the AGM in person. Alternative arrangements have been made for all unitholders to be able to participate in the AGM by:

- (a) watching the proceedings of the AGM online through a "live" audio-visual webcast via a smartphone, tablet or computer, or listening to the proceedings through a "live" audio-only stream via a telephone;
- (b) submitting questions in advance of the AGM or during the AGM via an online chat box; and
- (c) voting by appointing the Chair of the AGM as proxy at the AGM.

Please see paragraph 5 below for these alternative arrangements.

The Trustee-Manager's Chair, Mr Yong Lum Sung, and CEO, Mr Brian McKinley, along with other members of the board, will provide a business update and conduct the formal proceedings of the AGM by way of electronic means.

5. ALTERNATIVE ARRANGEMENTS FOR AGM

The following are the alternative arrangements which have been put in place for the AGM. Unitholders will need to complete the following steps to participate in the AGM:

(a) Pre-registration for "live" audio-visual webcast and "live" audio-only stream

All questions sent by post must be received by the Unit Registrar in the prescribed Question Form by 5.00 p.m. on 20 April 2022. In view of the current COVID-19 situation in Singapore, unitholders are strongly encouraged to submit their questions via the pre-registration website or by email.
- The Trustee-Manager will consider all questions and endeavour to address all substantial and relevant questions received in advance from unitholders. Answers to such questions received in advance will be made available on the SGX-ST website at the URL <u>https://www.sgx.com/securities/company-announcements</u> and APTT's corporate website at the URL <u>https://investor.aptt.sg/newsroom.html/year/2022</u> before 10.00 a.m. on 23 April 2022, 72 hours prior to the closing date for the lodgement of the proxy forms (10.00 a.m. on 26 April 2022).

- Please note that it is important for unitholders to submit their questions in advance in the manner and by the deadline stipulated above, if unitholders are unable to attend the "live" audio-visual webcast of the AGM online.
- For questions that are submitted after the stipulated deadline of 5.00 p.m. on 20 April 2022, the Board will address the substantial and relevant questions during the AGM.

Alternatively, unitholders may submit questions to the Chair of the AGM, in relation to APTT's business or resolutions to be tabled for approval at the AGM, "live" during the audio-visual webcast of the AGM via an online chat box.

The Trustee-Manager will, within one month after the date of the AGM, publish the minutes of the AGM on the SGX-ST website at the URL <u>https://www.sgx.com/securities/company-announcements</u> and APTT's corporate website at the URL <u>https://investor.aptt.sg/newsroom.html/year/2022</u> and the minutes will include responses to the questions received in advance and via the online chat box.

(c) Voting by proxy

Unitholders will **not** be able to vote during the "live" audio-visual webcast or "live" audioonly stream of the AGM on the resolutions to be tabled for approval at the AGM. Instead, a unitholder (whether individual or corporate) who wishes to exercise his/her/its voting rights at the AGM must submit a Proxy Form appointing the Chair of the AGM as proxy to vote on his/her/its behalf at the AGM, in accordance with the instructions provided in the Proxy Form:

- A unitholder (whether individual or corporate) appointing the Chair of the AGM as proxy must give specific instructions as to his/her/its manner of voting, or abstentions from voting, in respect of a resolution in the Proxy Form, failing which the appointment of the Chair of the AGM as proxy for that resolution will be treated as invalid.
- The Proxy Form must be submitted in the following manner:

In view of the current COVID-19 situation in Singapore, unitholders are strongly encouraged to submit their completed Proxy Forms electronically by email.

 Investors who hold their units through relevant intermediaries as defined in Section 181 of the Companies Act 1967 of Singapore (including SRS Investors) and who wish to exercise their votes should approach their respective relevant intermediaries (including their respective SRS Approved Banks) to submit their voting instructions by 5.00 p.m. on 18 April 2022, in order to allow sufficient time for their respective relevant intermediaries to in turn submit a Proxy Form to appoint the Chair of the AGM to vote on their behalf no later than the Proxy Deadline.
